# **STATE SUPPORT**

Residents under mandatory evacuation because of wildfire could be eligible for evacuation-related expense reimbursements under their current insurance policy. Additional Living Expenses coverage typically includes food and housing costs, furniture rental, relocation and storage, and extra transportation expenses, among other costs.

Commissioner Lara also announced a free two-day insurance support workshops on <u>January 18 and 19 in Santa Monica</u> and <u>January 25 and 26 in Pasadena</u> to help survivors understand their insurance policies and the claims process
